Notice is hereby given that the resolutions set out below are proposed for approval by the Members of Privi Speciality Chemicals Limited ("the Company") by means of Postal Ballot, only by remote e-voting process ("e-voting") being provided by the Company to all its Members to cast their votes electronically, pursuant to the provisions of Section 110 read with Section 108 of the Companies Act, 2013 ("Act") and Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended (the "Management Rules"), and various circulars issued by the Ministry of Corporate Affairs, Government of India (the "MCA Circulars"), Secretarial Standard on General Meetings issued by the Institute of Company Secretaries of India ("SS-2") and any other applicable law, rules and regulations (including any statutory modification(s) or re-enactment(s) thereof, for the time being in force).

Based on the recommendation of the Nomination and Remuneration Committee, the Board of Directors of the Company at their meeting held on November 06, 2023 considered and approved the appointment of Mr. Hemang Gandhi as Additional Director in capacity of Non-Executive Independent Director of the Company for a period of 5 years commencing from November 07, 2023 upto November 06, 2028 subject to the approval of the shareholders through postal ballot by way of Special Resolution.

Mr. Hemang Gandhi has forged an illustrious career marked by a strong focus on investment banking, fostering invaluable relationships with Indian corporate and private equity firms. His expertise spans diverse industries including engineering, logistics, travel and tourism, food processing, specialty chemicals, and media & entertainment.

Mr. Hemang Gandhi is qualified to be appointed as Additional Director in terms of Section 164 of the Companies Act, 2013 ("the Act") and have given their consent to act as Director. The Company has also received declarations from him, confirming that he is not debarred from holding the office of director by virtue of any order passed by the Securities and Exchange Board of India or any other such authority.

The Company has also received notice under Section 160 of the Act from a member proposing the candidature of Mr. Hemang Gandhi for the office of Non-Executive Independent Director of the Company.

Details of Mr. Hemang Gandhi pursuant to the provisions of (i) the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"); and (ii) Secretarial Standard on General Meetings ("SS-2"), issued by the Institute of Company Secretaries of India, are provided in the "Annexure" to the Postal Ballot Notice. He shall be paid remuneration by way of Sitting fees for attending meetings of the Board or Committees thereof or for any other meetings as may be decided by the Board, reimbursement of expenses for participating in the Board and other meetings and profit related commission within the limits stipulated under Section 197 of the Act.

In accordance with the provisions of Section 149 and 152 of the Act and Regulation 17 of the Listing Regulations, appointment of a Non-Executive Independent director requires approval of members of the Company by way of a Special resolution.

Accordingly, the approval of Members is sought for appointment of Mr. Hemang Gandhi as Non-Executive Independent Director of the Company.
