Notice is hereby given that the resolutions set out below are proposed for approval by the Members of Privi Speciality Chemicals Limited ("the Company") by means of Postal Ballot, only by remote e-voting process ("e-voting") being provided by the Company to all its Members to cast their votes electronically, pursuant to the provisions of Section 110 read with Section 108 of the Companies Act, 2013 ("Act") and Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended (the "Management Rules"), and various circulars issuedby the Ministry of Corporate Affairs, Government of India (the "MCA Circulars"), Secretarial Standard on General Meetings issued by the Institute of Company Secretaries of India ("SS-2") and any other applicable law, rules and regulations (includingany statutory modification(s) or re-enactment(s) thereof, for the time being in force).

Based on the recommendation of the Nomination and Remuneration Committee, the Board of Directors of the Company at their meeting held on November 06, 2023 considered and approved the appointment of Mr. Hemang Gandhi as Additional Director in capacity of Non-Executive Independent Director of the Company for a period of 5 years commencing from November 07, 2023 upto November 06, 2028 subject to the approval of the shareholders through postal ballot by way of Special Resolution.
